Ethics Committee Nominations: Each Council member has two appointees. They will be nominated and approved tonight.

Wastewater Treatment Plant Project: City Manager Dove reported that she had met with John McClellan and Kenny Green of G. B. Turnipseed Engineers to discuss new funding with the USDA for the expansion project. With this funding, for each \$1m loaned, we could potentially get \$3m in grant funding. The project is still on hold by EPA. If we are able to get the funding we could include Campbell's Crossing. GBT already has the majority of the paperwork done. Council would need to approve to proceed. The upfront costs for fees would be in the range of \$5,000.00 +/- . Looking for additional areas to cover; apply for \$6m and go down.

NEW BUSINESS:

Consulting Proposal-Kirby Glaze: Mr. Glaze presented a proposal for consulting services on the Public Safety Building project. They provide services from the concept of the project to the construction of the project. They look at what the project is and what the needs are. They help develop a budget, locate funding sources, work with the architect closely on the specs; they qualify the contracts, go over contractor pricing, and present a final contract. They act as the owner's representative. They will work in phases; if they are not needed through the full project, the owner can terminate the consulting contract at any point in any phase. The phases are broken into time periods; most of the time happens at the end of the phases. Mayor Culpepper questioned if they had worked on a public safety building project before; they have not specifically done public safety buildings. They have done City halls, renovations, etc. It will depend on the architect and the public safety personnel. Mayor Culpepper expressed a concern that their services

NEW BUSINESS (cont'd):

Consulting Proposal-Kirby Glaze (cont'd): overlap the architect's; what are the advantages of using a consulting firm? The architect is design driven; the consulting firm is budget driven. They spend time with the architect and personnel so the City Manager does not have to. The architect does the design and makes sure it is in compliance with code; they do not but they manage the process for well informed decision making. Construction contingencies are shifted on the contractor. They will negotiate line item for contingencies (for unforeseen happenings). There is no profit to come from contingency. At the end of the project could earn 20% of contingency as bonus. Also do budget for line item "owner's contingency". Councilman Thigpen questioned why renovate instead of new building. Mr. Glaze recommends the need to preserve existing architecture. He supports the proposal process not the "design, bid, and build" process. Councilman Thigpen expressed his support of the phase process. Mayor Culpepper asked how they would handle to other fire station; he sees that working with one contractor for both projects would be beneficial. He recommends that the new structure should have the same architectural (integrity) design (as belonging in Harlem). The "City sets the standard".

Proclamation-Arbor Day: A resolution has been prepared for Council's approval to designate February 16, 2010 as Arbor Day in Harlem. A tree will be planted in front of the Library.

Bandstand (Gazebo) Bid Award: City Manager reported that two bids had been received. Due to the project being under \$25,000.00, we did not have to go through the sealed bid process in which you have to have three bids. The bids received are from Ken Coleman in the amount of \$20,458.50 and Spratlin & Son in the amount of \$16,495.00. The project is for the rehab of the existing building only and the addition of a handicap ramp. The current funding available is \$10,000.00 from Commissioner Scott Dean and \$12,000.00 that the City currently has existing. We would have to do the landscaping, decorative lighting, etc. Council will need to approve the awarding of the bid and to proceed with the project.

Resolution-RBEG Grant: City Manager Dove reported that we will be submitting an application for a RBEG Grant in the amount of \$99,999.00 for the pavilion. We will be renovating the existing fire building. Ken Coleman pledged to donate in-kind services. This project is in keeping with the Charrette and the City's Comprehensive Plan. Council will need to approve to proceed.

The bids came in higher than the funding we have for the project. Mayor Culpepper asked City Engineer McClellan to look at the possibility of a reduction in the actual crosswalks. Mr. McClellan had spoken with Mandy Corporation about this; they could do but they would have to revise the bid numbers (unit prices). We would have to go to bid again. Councilman Blalock wanted City Engineer McClellan's opinion on the material. Mr. McClellan commented that an addendum was done to consider doing brick print. Mr. McClellan gave a comparison on both the brick print and the XD material. He was not as confident on the material of the brick print; he leans towards the XD material.

Change Order #1-S. Louisville Street Waterline: Mr. McClellan addressed Council. The total for deducts and additions is \$9,031.58. This will come from the contingency portion of the contract. There are no additional funds due from the City. The changes included the change out of nine connections outside the City that had to be made larger. Mayor Culpepper asked how far along the project was; 85% complete. The project could possibly be completed within three weeks. The sewer portion of the project has been closed out. There is about \$6,000.00 left in contingency on the waterline portion in the event something else comes up.

HPC/Housing Authority-Phil Turner: Mr. Turner is the Chairman of both the Historic Preservation Commission and the Harlem Housing Authority Board.

NEW BUSINESS (cont'd):

HPC/Housing Authority-Phil Turner: Mr. Turner gave an update on some improvements that have been made at the Housing Authority that includes new mailboxes, new flag pole, new front sign and planter, new handicap parking sign and parking lot. The fence has been taken down at the office building; the area is more pleasing to look at.

Mr. Turner reported on receiving a letter from a City official pertaining to a piece of property that is in disrepair. There was mention of demolition by neglect. This may be the initiating factor in contacting the property owner. If so, he will proceed as necessary, but it will still fall on the City to enforce.

Mr. Turner presented a drawing to Council in regards to the "Twice the Ice" property/business. The only two items that came before HPC for approval pertained to the stucco and crush and run. These were approved based on the City's recommendations. He feels that the property could be improved (boxes on top of building). The drawing is his idea on how to improve it. The picture shows a false front with a tin roof that looks like a cabin; this would cover the two boxes on top. Mayor Culpepper responded that it would need to be reviewed.

Other: Councilmember Thigpen reported that with the change in ownership on the cable in Harlem (Charter to Cobridge) the e-mail addresses that are in place now will no longer be available starting in April.

Councilmember Blalock questioned what a master plumber needs to do to be licenses in the City; he suggested we look at the County's standards and North Augusta's. Currently if a plumber is working in the City of Harlem, they must register with the City and provide a copy of their state license, proof of insurance coverage and bonding. There is a fee of \$20.00 to be paid.
