Harlem has been working on a golf cart plan to support the installation of golf cart crossings at Trippe St. and N. Louisville St., and also at Bell St. and W. Milledgeville Rd. The plan provides the evidence needed by Georgia DOT for the crossings.

The City would like your thoughts about golf carts operating on city streets. Comments may be sent to David Jenkins, City of Harlem, P.O. Box 99, Harlem, GA 30814 or at djenkins@harlemga.org.

The City will also have a Community Open House on April 28th at 3:30 p.m. and a Public Hearing on April 28th beginning at 6:30 p.m. Both will be in the Municipal Courtroom at the Public Safety Building at 110 W. Milledgeville Rd. A second Public Hearing will be held at the Harlem Planning Commission meeting on May 3, 2022 beginning at 6:00 p.m. at the same location.
