The 2021 Harlem Comprehensive Plan is the growth path for Harlem and the guiding document for the community's projects for the next five years. A community survey is now available (https://www.surveymonkey.com/r/HarlemCP21) to gather citizens' thoughts on the future of Harlem. With recent and projected growth due to downtown development and annexations, Harlem officials are facing important decisions. The City established a steering committee to guide this planning process and is working with the CSRA Regional Commission to develop the document. The final comprehensive plan will include community goals, a work program of activities, and information on economic development, broadband, housing, community facilities, cultural resources, and land use. Once the plan is drafted, there will be a second public hearing to receive final public comments.

PEDDLING IN THE CITY OF HARLEM

The word *Peddle*, according to the Cambridge Dictionary, is a verb: to travel about selling one's wares; to seek to disseminate, give out. But, is peddling - i.e. going door-to-door, soliciting - a legal act within the purview of Harlem's city limits? According to the official code of the City of Harlem, Chapter 8, Article 2, Division 2, "Any person peddling, soliciting, or canvassing within the city shall be required to register and obtain an identification card as provided by [Sect. 8-71. Peddler's registration required]." The Harlem Police Department has received many calls throughout the hot summer months regarding "strange people walking" perambulating from house-to-house, knocking on doors, approaching whomever attentive in attempt to sell items or services, offer immediate estimates and quotes, or to simply hand-out a pamphlet or flyer. More often than not, peddlers within our city's limits are respectable, business-minded people who are courteous and genuinely seek to offer a "real" product or service. There are, however, some who will use peddling as a ruse - those who seek to profit illicitly. Harlem's Police Chief, "Rob" Lewis, is immediately notified when administrators at City Hall issue an approved peddler's license. Chief Lewis encourages all of Harlem's citizenry to visit Harlemga.org and read the code section addressing Peddlers and Solicitors, to better understand what is legally required of persons soliciting business at your doorstep. Be vigilant, look out for your neighbors, and please do not hesitate to call the Harlem P.D. to question a peddler's license or report suspicious persons and activities in or around your neighborhood.
